

COURSES OF INSTRUCTION

Presented here is the entire curriculum of the college, with information about the programs of study and content descriptions of the courses. Beside the title of each course, the academic term or terms in which it is normally scheduled will be given. This is subject to change; the actual schedules are published during February each year.

Each of the college-wide programs begins with an explanation of both a general and specific nature. Each division's listing is preceded by an explanation of the requirements in the categories of foundation courses and area major, electives, and senior thesis. The course listings that follow are presented under departments, which are arranged alphabetically.

Courses are coded as follows. The initial letter H, SS, NS, L, E, or I indicates the division: Humanities, Social Sciences, Natural Sciences, Languages, Education or International Studies. The department is shown by two letters following the division letter: Li for Literature, Ec for Economics, Bi for Biology, and so on. PE stands for Physical Education. X is used for Introduction to Christianity, CP is used for the Perspective Studies courses in the General Education Program, CW is used for the Special Courses, and RE is used for the Regional Studies.

The first digit of the number has the following meanings. The numbers 001 to 094 indicate College required courses. Foundation courses and introductory courses prerequisite to further work are numbered from 100 to 199, intermediate level courses from 200 to 299. The 300s are advanced undergraduate courses which are open also to graduate students.

The second digit indicates classification within a department. Economics, for example, is subdivided into economic theory, statistics and econometrics, economic policy, development and history, banking and finance, international economics and business administration.

The third digit shows the sequence of courses within the above system. Standard numbers are applied to the senior thesis (095-6-7), advanced seminars and studies (392-3-4), and teaching methods (290, 291, 292 and 293).

A hyphen between course numbers indicates that the course extends over more than a single term and that the first term or terms are

prerequisite to the concluding term.

A comma between numbers indicates that any term of that course may be taken independently of the others.

The language of instruction is indicated by the individual letters or combinations "J," "E," "J, E" or "E, J" following the course number. "J" indicates Japanese; "E," English. "J, E" or "E, J" indicates that the same course will be taught in one language one term and in the other during another term, or, for some courses taught by more than one instructor, that the course will be taught in both languages. For courses with lectures on both Japanese and English, the letter that appears first indicates

the primary language of instruction.

For foreign language and literature courses, other abbreviations may be used to indicate language of instruction.

For more detailed information on languages to be used for particular courses, the syllabus should be consulted.

In general, the number of units assigned to a course corresponds to the number of class hours per week. It is assumed that the student will spend two hours in outside preparation for each hour in class. Laboratory periods not requiring outside preparation carry one unit of credit. The class hour is 70 minutes; laboratory periods are from 140 to 210 minutes.

Note: Terms (spring, etc.) and languages of instruction (E, J) as indicated in the course number in this bulletin do not necessarily apply for every academic year. Please refer to the *Course Offerings and Guide to Academic Regulations* published annually by the Educational Affairs Group for detailed information.
